

## GlobalConnect General Website Privacy Statement

GlobalConnect has a standing commitment to safeguard the privacy of information (if any) entrusted to us. The privacy principles and procedures set forth below are intended to tell you how we collect, use, and distribute user information via our primary public Website ([www.globalconnectlimited.com](http://www.globalconnectlimited.com)). This statement also applies generally to all websites operated by GlobalConnect (and its affiliates). This statement does not cover information collected from sources other than GlobalConnect websites.

### Types and uses of personal information

If you use this Website, personally identifiable information about you may be collected and processed by GlobalConnect employees. In general, we only collect such information you knowingly provide it to us. Additionally, GlobalConnect may automatically collect or process personally identifiable data (such as your Internet domain or IP address) as part of the operation of this Website or during the course of your activities on or use of this Website. In nearly all cases this data may be collected or processed by, and transferred to, GlobalConnect facilities possibly in other countries where GlobalConnect does business; the data is then subject to the legal systems of those countries. By using this website (which resides in part on servers located in the United States), you unambiguously consent to any collection, processing, transfer or use of any data. If you do not consent to any collection, processing, transfer or use of such information, please discontinue use of this Website.

### Sharing with other GlobalConnect companies

We may share much of our data, including personally identifiable information about our sites' visitors, with our affiliates. To the extent that these entities have access to your information, they will follow privacy practices no less protective than our practices described in this document, to the extent allowed by applicable law.

### How personal information is shared with third parties

Without the user's consent, GlobalConnect will not sell, trade, or disclose the user's personally identifiable information to third parties that want to market products to the user. However, GlobalConnect may disclose information to third parties contracted by us to provide specific services. Additionally, GlobalConnect may disclose information when required by subpoena, search warrant, or other legal process, or in response to activities that are unlawful or a violation of GlobalConnect rules for use of the Website, or to protect and defend the rights or property of GlobalConnect.

### Security measures

GlobalConnect has implemented technological and operational security processes to protect your personally identifiable information from loss, misuse, alteration, or unintentional destruction. While no security measure can guarantee against compromise, GlobalConnect regularly reviews and updates its security measures in an effort to provide appropriate security for all information held by GlobalConnect.

GlobalConnect reserves the right to change, modify, or update this statement at any time without notice. We indicate the date of the current statement below, so you know when it was last updated.

### Access and accuracy

GlobalConnect wants to maintain only accurate information about users of the site. You can request individual information that has been gathered about you by contacting GlobalConnect. Upon receipt of

appropriate identification information, GlobalConnect will provide you with access to the personally identifiable information that it maintains about your use of GlobalConnect websites or which you have supplied to GlobalConnect via a GlobalConnect Website. If you find factual inaccuracies, please notify GlobalConnect so that they may be corrected.

### **Data retention**

GlobalConnect will not retain your personal information longer than is necessary for the purpose it was collected.

### **Children**

GlobalConnect takes children's privacy seriously. GlobalConnect asks children under the age of 13 not to send any personally identifiable information to GlobalConnect websites without the consent of their parents or guardians. GlobalConnect encourages all parents and guardians to instruct their children in the safe and responsible use of personal information on the Internet. GlobalConnect will not knowingly collect, use, or disclose to third parties any personal information collected from children, and we are committed to complying with applicable laws and requirements, such as the United States' Children's Online Privacy Protection Act (COPPA).

### **Linked Websites**

We may provide links to third party sites. Since we do not control these websites, we encourage you to review the privacy statement posted on these (and all) third party sites. GlobalConnect is not responsible for the privacy statements or practices of sites and services controlled by other companies or organizations.

### **Use of cookies**

GlobalConnect may use "cookies" in connection with operation of its websites. Cookies are small pieces of information that are stored on your computer by the GlobalConnect Website server. Cookies are used for record-keeping purposes—the stored information can be retrieved by the GlobalConnect Website server when you return to the Website. This allows GlobalConnect to personalize or regulate the use of the site, and also permits GlobalConnect to automate the access and data-entry functions of the site (e.g., login information), to store on-line ordering information for purchases you may make while visiting the site, and to tailor the appearance or presentation of the site to your preferences or interests. In general, we do not use cookies to track the navigational habits of identified users without the user's consent. If you visit our sites to read or download content, much of the information we do collect is statistical only (e.g., the domain from which you access the Internet, the date and time you access our site, and the Internet address of the Website from which you linked directly to our site) and not personally identifiable. We use this information about the number of visitors and their use of the sites in aggregate form to make our sites more useful and attractive to you.
